- 3. <u>Wisconsin River Total Maximum Daily Load (TMDL) Study Ann Hirekatur.</u>
  <u>Discussion:</u> Ann Hirekatur, DNR project manager, presented on the Wisconsin River TMDL. The presentation covered:
- Need for more consistency state-wide regarding the development of TMDLs;
- How the river got to its current condition:
  - Scope of the TMDL upstream from Lake Wisconsin;
  - The condition of Castle Rock/Petenwell area as the driving force behind the TMDL;
  - Political and financial background;
  - o Responsibilities of the DNR and the US Army Corps of Engineers:
  - 19 monitoring stations on the river's main stem, 28 on tributaries, and 21 in reservoirs to determine Total Suspended Solids (TSS) and Total Phosphorous (TP);
- Where the project is going:
  - Monitoring continues, modeling has begun, result to be allocations determination;
  - o The TMDL development process:
    - Draft TMDL will undergo an internal review and public comment:
    - The final TMDL will be submitted to the EPA for approval, anticipated to be by 2017;
    - The TMDL will be implemented;
- The TMDLs impact to municipalities:
  - MS4 permits were defined;
  - o Future issue of unregulated/unpermitted municipalities contributing to issues downstream;
  - How allocations and baseline loads are to be calculated;
  - Compliance schedules for municipalities with MS4 permits;

- March 28, 2013 DNR symposium on TMDLs to be held in Stevens Point;
